

Heart Tickets Sweepstakes

1. **Eligibility** The Extreme Sports Sweepstakes (the "Sweepstakes") is open to Arizona residents who are at least eighteen (18) years old at the time of entry. 4. **Sweepstakes Period** The Sweepstakes begins on August 7th, 2025, at 9:00 AM MST and ends on August 11, 2025, at 11:59 pm MST (the "Sweepstakes Period"). Entries submitted before or after the Sweepstakes Period will be disqualified. Limit of one entry per email address. Submissions will be accepted for the duration of the Sweepstakes.

Entries exceeding this limit will be void.
6. **Winner Selection** On or about August 12, 2025, the Sponsor will select the potential winner in a random drawing from all eligible entries received. The odds of being selected depend on the number of entries. The Sponsor will attempt to notify the potential winner via email and telephone. If the potential winner cannot be contacted using the email or telephone number provided within two (2) days after the first attempt, the Sponsor may select an alternate winner.
7. **Winner Requirements** The potential winner will be required to complete, sign, and submit a Declaration of Compliance within two (2) days of the first attempted notice to claim their prize. The winner must provide proof of age to claim prizes. If a potential winner cannot be contacted, fails to submit the Declaration of Compliance within the required time period, or the prize communication is returned as undeliverable, they forfeit the prize. The prize package must be picked up by August 16, 2025, or the prize is forfeited. In the event of disqualification, the Sponsor may award the prize to an alternate winner by random drawing.
