

Mile High PBR + Espire Sports Sweepstakes

1. **Eligibility** The Mile High PBR + Espire Sports Sweepstakes (the "Sweepstakes") is open to Arizona residents who are at least eighteen (18) years old at the time of entry. Employees of Findlay Toyota Center and Oak View Group are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations.
2. **Sponsorship** The Sweepstakes is sponsored by Findlay Toyota Center, located at 3201 N. Main St., Prescott Valley, Arizona 86314 (the "Sponsor").

4. **Sweepstakes Period** The Sweepstakes begins on March 21st, 2025, at 9:00 AM MST and ends on April 2, 2025, at 11:59 pm MST (the "Sweepstakes Period"). Entries submitted before or after the Sweepstakes Period will be disqualified. Limit of one entry per email address. Submissions will be accepted for the duration of the Sweepstakes.
5. **How to Enter** Online entry is available by visiting our sweepstakes entry form and following the directions to fill out and submit the entry information. No purchase necessary. Entry form link: <https://bit.ly/ETWPBR>. There is a limit of one (1) entry per email address for the duration of the Sweepstakes Period, regardless of the method of entry. Entries exceeding this limit will be void.
6. **Winner Selection** On or about April 4, 2025, the Sponsor will select the potential winner in a random drawing from all eligible entries received. The odds of being selected depend on the number of entries. The Sponsor will attempt to notify the potential winner via email and telephone. If the potential winner cannot be contacted using the email or telephone number provided within two (2) days after the first attempt, the Sponsor may select an alternate winner.
7. **Winner Requirements** The potential winner will be required to complete, sign, and submit a Declaration of Compliance within seven (7) days of the first attempted notice to claim their prize. The winner must provide proof of age to claim prizes. If a potential winner cannot be contacted, fails to submit the Declaration of Compliance within the required time period, or the prize communication is returned as undeliverable, they forfeit the prize. The prize package must be picked up by April 11, 2025, or the prize is forfeited. In the event of disqualification, the Sponsor may award the prize to an alternate winner by random drawing.
