

## Parker + Stay + Play Sweepstakes

1. **Eligibility** The Parker + Stay + Play Sweepstakes (the "Sweepstakes") is open to Arizona residents who are at least eighteen (18) years old at the time of entry. Employees of Findlay Toyota Center, Forest Villas Hotel, and Espire Sports are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations.
2. **Sponsorship** The Sweepstakes is sponsored by Findlay Toyota Center, located at 3201 N. Main St., Prescott Valley, Arizona 86314 (the "Sponsor").
3. **Agreement to Official Rules** Participation in the Sweepstakes constitutes the entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.
4. **Sweepstakes Period** The Sweepstakes begins on September 30th, 2024, at 9:00 AM MST and ends on October 13, 2024, at 11:59 pm MST (the "Sweepstakes Period"). Entries submitted before or after the Sweepstakes Period will be disqualified. Limit of one entry per email address. Submissions will be accepted for the duration of the Sweepstakes.
5. **How to Enter** Online entry is available by visiting our sweepstakes entry form and following the directions to fill out and submit the entry information. No purchase necessary. Entry form link: <https://bit.ly/ETWParker>. There is a limit of one (1) entry per email address for the duration of the Sweepstakes Period, regardless of the method of entry. Entries exceeding this limit will be void.
6. **Winner Selection** On or about October 14, 2024, the Sponsor will select the potential winner in a random drawing from all eligible entries received. The odds of being selected depend on the number of entries. The Sponsor will attempt to notify the potential winner via email and telephone. If the potential winner cannot be contacted using the email or telephone number provided within two (2) days after the first attempt, the Sponsor may select an alternate winner.
7. **Winner Requirements** The potential winner will be required to complete, sign, and submit a Declaration of Compliance within two (2) days of the first attempted notice to claim their prize. The winner must provide proof of age to claim prizes. If a potential winner cannot be contacted, fails to submit the Declaration of Compliance within the required time period, or the prize communication is returned as undeliverable, they forfeit the prize. The prize package must be picked up by October 17, 2024, or the prize is forfeited. In the event of disqualification, the Sponsor may award the prize to an alternate winner by random drawing. Only one (1) alternate drawing will be held, after which the prize will remain unawarded.

11. **Disputes** Disputes will be resolved individually without resort to any form of class action, exclusively by the appropriate court located in Yavapai County, Arizona.
