

## Happy Together Tour + Bucky's Casino Sweepstakes

6. **Winner Selection** On or about July 8, 2024, the Sponsor will select the potential winner in a random drawing from all eligible entries received. The odds of being selected depend on the number of entries. The Sponsor will attempt to notify the potential winner via email and telephone. If the potential winner cannot be contacted using the email or telephone number provided within three (3) days after the first attempt, the Sponsor may select an alternate winner.
7. **Winner Requirements** The potential winner will be required to complete, sign, and submit a Declaration of Compliance within three (3) days of the first attempted notice to claim their prize. The winner must provide proof of age to claim the gambling-related prizes.
