

Brit Floyd Tickets + VIP Experience Sweepstakes

1. **Eligibility** The Brit Floyd Tickets + VIP Experience Sweepstakes (the "Sweepstakes") is open to US residents who are at least eighteen (18) years old at the time of entry. Employees of Findlay Toyota Center and Oak View Group are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations.
2. **Sponsorship** The Sweepstakes is sponsored by Findlay Toyota Center, located at 3201 N. Main St., Prescott Valley, Arizona 86314 (the "Sponsor").

The odds of being selected depend on the number of entries. The Sponsor will attempt to notify the potential winner via email and telephone. If the potential winner cannot be contacted using the email or telephone number provided within two (2) business days after the first attempt, the Sponsor may select an alternate winner.
